INSTRUCTIONS FOR USE	
Consumption	1,5 kg/m ² and mm of thickness
Base	The substrate has to be equally absorptive, dry, homogenous, solid, supporting, stabile, not frozen (over +5°C), clean and free of dust, oil, grease remains, wax, falling of colour, or dirt. Coatings have to be air dry and the reinforced cement floor base has to be at least 28 days old.
Base preparation	Before applying the adhesive, anhydride cement floor base (mechanically ground), light concrete, gas concrete and gypsum coatings have to be impregnated with the polymer dispersion KEMACRYL (KEMAGRUND S) diluted with water in the ratio 1:1, for impregnation of compact surfaces is KEMAGRUND A, diluted with water in the ratio at least 1:1, recommended. Surface has to be sufficiently flat to enable setting of ceramic in cca. 3-5 mm thick layer of adhesive. Bigger unevenness of the floor (0.5-3 cm) is levelled by application of levelling mass LINEA 820 M (LINEA 20) to the connective coating KEMACRYL, diluted with water in the 1:1 ratio. When laying new ceramic tiles to the existing ones, the existing tiles have to be impeccably attached to the surface (must not sound hollow when knocked on). Before laying, they have to be washed with hot water and detergent to remove grease. Before setting of lining, floor bases with underfloor heating have to be heated and cooled in accordance with heating rules, cast asphalt surface has to be sandblasted.Surface can change its shape only in a limited amount after lining has been applied. On substrate constructions, which are contracting and extending, lining has to be laid as late as possible. A guideline is that lining can be applied cca. 3 months after the construction on a concrete surface and wall with connected bricks. In substrate constructions, where expected effects are finalised, the aforementioned time limit can be shorter.
Mix ratio	7 - 8 I of water per 25 kg of dry mixture
Mix time	Mix dry mixture with clean water into a homogenous mass of medium plastic consistency without clods. Leave it to rest for 5 minutes to intumesce and then stir it again thoroughly just before using it. If necessary, add some water. Water must not be added to the adhesive that is already in the binding phase.
Mix tool	Mix adhesive with electrical mixer with a suitable equipment for mixing in a clean container. Free fall mixers should not be used.
Installation	Apply a thin adhesive layer on a cleaned surface using a trowel. Apply the next layer to a fresh contact layer using a notched finishing trowel. Ceramic tiles should be pressed into a fresh glue before a film forms on the adhesive. Adhesives in joints should be removed before it dries. By removing the adhesive from the joints the grouting compound can be applied and possible stains on the joints are prevented. If setting tiles on more demanding surfaces (outdoor, pools) and in other areas that require perfect adherence of ceramic tiles, the use of combined procedure is recommended. At the combined procedure the thin-layer adhesive is applied on both surfaces; on the surface to be lined as well as on the back side of the ceramics.
Tool	Choose a notched finishing trowel with teeth depth of 4 to 6 mm, which assures 2 to 3 mm thick adhesive layer.
Cleaning of tool	Clean tools immediately after use before adhesive hardens. Hardened material on tools can only be removed mechanically.

Warnings	 Times specified in the techical sheet were measured at the temperature of +23°C and relative air humidity of 50 %. Higher temperatures reduce, while lower temperatures prolong those times. Use only recommended amount of water. Use only mixture from undamaged packaging. Do not overdo the layer thickness. Gypsum board panels should be at least 10 mm thickness with maximum moistness of 5%. To achieve later water-resistance under the tiles a layer of Hidrostop Elastik is recommended. Protect freshly installed material from freezing, rain and other weather conditions. The material should not be used at (surface, air, material) temperatures lower than +5°C. It is not necessary to wet the lining before application. When setting natural stone, there is a danger of stone being coloured, so prior test setting is recommended. Due to different working conditions presence of a film on the adhesive should be checked with a finger if membrane is formed on the surface of the applied adhesive. Application of adhesive in direkt sun and draught is not allowed.
	Recommendation: Remains of unhardened/unset material had to be removed in accordance with the legislation.
